

# Kittywalk® GAZEBO

## PARTS INCLUDED:

- 1 Gazebo unit
- 6 straight bottom tightening rods
- 1 Flag
- 4 turning clasps



1) Open unit as shown



2) Connect the bottom parts using 2 turning clasps spaced approximately 24" apart - as shown



3) Close the zippers of the triangular opening on top and connect the zippers to the silver catch-lock



5) Connect each of the 6 rail strengthening bars by weaving each bar through the netting along the top and bottom of unit and connect to the 2 vertical posts on each corner



6) You can connect the Gazebo to the following Kittywalk® Outdoor Enclosures: Lawn Version, Deck & Patio, Penthouse, Clubhouse, T-Connect, 2/Curves, 4/Curves, Town & Country. To do so simply remove the clear plastic door



7) And use the Velcro straps all around to connect the Gazebo to the Kittywalk® unit of your choice



7) To lock the door use 1 turning clasp about 4" from the top and the other turning clasp about 4" from the bottom.

Periodically check for gaps or holes chewed through by rodents, rabbits or squirrels. Unit will last longer if brought in during bad weather.

## Tips for Shy Pets

*What happens if your pet doesn't take an immediate liking to the Kittywalk® Gazebo?*

Sometimes customers say, "I can't seem to get my pet onto my Kittywalk® Gazebo. It's afraid and won't go on willingly!" That is not an unusual reaction for a pet. To familiarize your pet with the Gazebo, follow these few simple instructions. More than likely your pet will take to it as his own domain and will want to spend time there. Use the following steps to get your pet familiar with the Gazebo.

- Put your Kittywalk® Gazebo inside your home, but not yet assembled, so that your pet can fully inspect and get used to the new items and scents at it's leisure.
- When your pet is comfortable near the un-erected Kittywalk® Gazebo—your pet will naturally want to explore it. Make a game of it with a pet toy if that helps.
- When your pet is comfortable near the un-erected Kittywalk® Gazebo, set the unit up indoors and let your pet become used to the newly erected Kittywalk® Gazebo.
- After he/she is comfortable playing in the Kittywalk® Gazebo indoors, set it up outdoors where you can visually supervise. Allow your pet to use it for short periods of supervised time at first -- then gradually increase the time over the next couple of days. This way your pet will get used to being in an increasingly familiar outdoor space.
- Go slowly. If at first your pet still will not go into the Kittywalk® Gazebo, try again the next day. Praise your pet when it makes advances.

### **\*IMPORTANT\***

- Remove collars – S-Hooks may get caught in netting – if you do not want to remove collars, cover S-Hook with duct tape.
- Never leave your pet unattended when using the Gazebo or any other Kittywalk® Systems outdoor product.
- Clip your pet's nails!
